No broker registration forms will be accepted at the auction. HAI is acting as agent of the Seller only. Broker is not a sub-agent of HAI. Under no circumstances will a Broker fee be paid if their client defaults on the purchase or a closing does not occur for any reason. HAI reserves the right to refuse to accept a Broker Registration Form if HAI has had prior contact with the Prospective Buyer concerning the subject Property. By submitting this Broker Registration Form to HAI, the Broker is hereby registering the Prospective Buyer as their client per the terms of this registration form. This form does not register the Prospective Buyer for the auction nor does it bind the Prospective Buyer to participate in the auction. For the Prospective Buyer to bid, he/she must attend the auction in accordance with the terms and conditions of the published auction sale, provide the required deposit and any other required documentation. In the case of a duplicate registration, the Broker who files the first complete Broker Registration Form will be considered the procuring broker.
