HAI reserves the right to refuse to accept a Broker Registration Form if HAI has had prior contact with the Prospective Buyer concerning the subject Property. By submitting this Broker Registration Form to HAI, the Broker is hereby registering the Prospective Buyer as their client per the terms of this registration form. This form does not register the Prospective Buyer for the auction nor does it bind the Prospective Buyer to participate in the auction.
